## **Correspondence:**

Rec'd Via Mail: The CGSTA certificate of Renewal for the Insurance policy. The Insurance policy has been renewed for the 2014 year.

# **New and Replacement Directors:**

At this time, before any other business was conducted, President Hughes brought a matter to the floor.

This matter pertained to the allegation brought before the General Membership by a CGSTA member at the June 29<sup>th</sup> General Membership Meeting at Kingsburg, CA. The allegation was that CGSTA was out of compliance with their own By Laws by having 12 directors per zone. This member stated paperwork in hand stated 4 directors per zone. As a result of this allegation a vote was held for the northern zone directors that were nominated at the General Membership meeting.

President Hughes advised the Board that on arrival home from the California State Shoot, she consulted the bound copy of the New By Laws that had been adopted Oct 17<sup>th</sup> 2011 pertaining to the allegation at the General Membership meeting of noncompliance by the board with 12 Directors per zone. President Hughes stated that she read the paragraph and it stated that 12 directors per zone for a total of 36 Total directors including the executive committee were allowed. On July 1, 2013, President Hughes called Bryan Cave, the attorney that handled the By Law revision and merger. President Hughes stated to Bryan Cave that she had in hand a bound and certified copy of the CGSTA By Laws on July and was verifying that all contents in the bound copy were just and true. With the confirmation from Bryan Cave, President Hughes was confident that the CGSTA was NEVER out of compliance with the By Laws as the paragraph in question states in the Bound copy "ARTICLE 12: DIRECTORS; Section 2: ( Paragraph 1) Number and Qualifications of Directors. The authorized number of directors shall be thirtysix(36), consisting of twelve (12) directors from each of the Northern Zone, Southern Zone and Central Zone. One of the directors shall be the immediate past president of the corporation who shall be known as the "Past President -Ex Officio" (provided, however, that if the immediate past president ceased to be president for any of the events set forth in subsections (1) through (3) of Section 5(a) of Article 12 of these bylaws, then the Board may appoint another past president to serve as Past President – Ex Officio. The qualifications for directors are that each shall (i) be a Lifetime member of this corporation prior to nomination, (ii) be a legal resident of the State of California and shall have been such for not less than six month and one day immediately

preceding his taking office as a director and (iii) have been a Member of this corporation for at least three full years immediately preceding his becoming a Board member. The following categories of persons may not be directors: Those who are the parent, spouse, child, brother or sister of a director."

It was determined that the CGSTA member who had brought this matter to General membership had been looking at a redline and rough draft copy of the By Laws. (The Board had asked, on June 30<sup>th</sup>, President Hauge if he had prior knowledge of this complaint. He stated that yes he had prior knowledge, but did not bring this matter up to the board at any of the 5 prior meetings that had been called for since he thought the membership should know about this and that the directors should have read the By Laws.) (A Note here; the Board

As the Board, operating with 12 directors per zone, was never out of compliance, it is stated here in these public minutes that the action taken at the June 29<sup>th</sup> 2013 General Membership meeting, in regards to the vote taken on above mentioned day, that vote is null and void. Directors Wyllie and Wood are hereby reinstated as Northern Zone Directors.

In addition, Central VP Hammond asked that the following persons be added to the Central Zone Director list: Bryan Craft, Kevin Erwin and Keith Baker and Mike Malone.

As stated in the June 30<sup>th</sup> Minutes, Mark Cohen had been nominated from the floor at the time of open nominations at the General Membership meeting. After accepting the nomination he disclosed that he was not in fact a life member of the CGSTA. He was not eligible at that time for seating as a director. Mr. Cohen paid his life membership June 30<sup>th</sup>, 2013 and sent via email a request to be seated as a director for the Southern Zone. His request was granted.

Secretary Robinson stated that the 2013/14 Shoot calendar was in the process of being finalized and that the final draft should be ready for online viewing about the first of Nov.

President Hughes stated that she would hold off on the committee selections until the next meeting as to allow the other Board members the opportunity to be present.
